Without limitation of any of the legal rights of harignee as the absolute Assignee of the rents, issues, and profits of said property, and by way of enumeration only, fesignor hereby irrevocably covenants and agrees that in the event of any default by Assignor under the said Notes or under the Mortgage above described, whether before or after the Note is declared to be immediately due, or righter before or after the institution of any legal proceedings to foreclose the lien of the Mortgage, or before or after any sale therein, forthwith upon and of Assignee, Assignor will surrender to Assignee and Assignee shritte entitled to take actual possession of the said property or of any part thereof, personally or by its agents or eccurreys, as for condition broken, and in Assignee's discretion Assignee may, with or without force and with resultance without process of law and without any action on the part of the Holder or Holders of the Notes or the Mortiage, enter upon, take and maintain possession of all or any part of said property together with all documents, books, ecords, papers, and accounts of Assignor relating thersto, and may exclude Assignor and Assignor's agents or juryants wholly therefrom and may in Assignee's own name as Assignee under this Assignment hold, operate, language, and control the said property and conduct the business thereof, either personally or by Assignee's agent) and may, at the expense of said property from time to time either by purchase, repair, or construction make a' increasary or proper repairs, renewals, replacements, useful alterations, additions, betterments, and improvements to the said property as to Assignee may seem judicious and may insure and reinsure the same, and may trazy, said property in such agencies and for such times and on such terms as to Assignee may seem fift forfulding (eases for terms). in such percels and for such times and on such terms as to Assignee may seem fit, including leases for terms expiring beyond maturity of the Indebtedness secured by the Mortgage, and may concel any lease for jublease for any cause or on any ground which would entitle Assignor to cancel the same, and may manage and operate the said property and carry on the business thereof as Assignee shall deem best and do everything in or about the said property that Assignor might do. Motwithstanding any other provisions hereof, so long as there shall exist no default in the payment of the Indebtedness or in the performance of any obligation, covenant or agreement herein or in said Mortgage or other instrument contained, Assignor shall have the right to collect when, but not before, due all rents, issues, and profits from said property and to retain, use and enjoy the same.

Without limiting the generality of the foregoing, this Assignment covers specifically any lease or leases demising all or portions of the following properties for the terms shown:

- Cancel or terminate such lease for any reason whatsoever irrespective of how such right of cancellation or termination is obtained, or permit the cancellation or termination thereof; or accept a surrender of such lease;
- Reduce the rent provided for in such lease; modify such lease in any way, either orally
 or in writing; or grant any concession in connection with such lease, either orally or in
 writing;

The failure of Assignee or any of the Assignee's agents or attorneys, successors or assigns to make use of any of the terms, provisions, and conditions of this is ignment for any period of time, at any time or times, shall not be construed or deemed to be a waiver of any of the Assignee's rights under the terms hereof, but Assignee or Assignee's agents or attorneys, successors, or assigns shall have full right, power and authority to enforce this Assignment or any of the terms, provisions or conditions hereof, and exercise the powers hereunder at any time or times that shall be deemed fit.

In accepting this Assignment the Assignee herein does not assume nor shall it be under any obligation whatever to perform any of the covenants, undertakings or promises on the part of the Lessor to be performed under any lesse which amy be entered into concerning the said property.

If Assignor shall pay all the Indebtedness when or before due and shall keep, observe and fully perform all the covenants, conditions, stipulations and agreements herein contained, then inis Assignment shall be mult and void and Assignee will, promptly upon Assignor's demand therefor, release any discharge this Assignment.

This Assignment shall be governed and controlled by the laws of the State of Illimnis.

This Assignment is executed by The Land Trustee, not personally but as Trustee and processed in the exercise of the power and authority conferred upon and vested in it as such Trustee (and suid Trustee hereby werrants that it possesses full power and authority to execute said instrument), and it is expressly understood and agreed that nothing herein or in said Note contained shall be construed as creating any liability on said Assignor or on said Trust personally to pay the said Note or any interest that may accrue thereon or any indebtedness accruing hereunder, or to perform any covenant either express or implied herein contained, all such liability, if any, being expressly waived by Trustee and by every now person or hereafter claiming any right or security hereunder, and that so far as the Assignor and its successors and said Trustee personally are concerned, the legal holder or holders of said Note and the owner or owners of the indebtedness accruing hereunder shall look solely to the premises hereby conveyed for the payment thereof, by the enforcement of the lien hereby created, in the manner herein and in said Note provided or by action to enforce the personal liability of the guarantor, if any.
