TOGETHER with all the improvements now or hereafter erected on the property, and all easements, e.g., appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property of this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to a fine "Property".

If Mortgagor has paid any precomputed finance charge, upon Mortgagor's payment of the entire outstanding principal balance and termination of the Equity Credit Line. Mortgagor shall be entitled to a refund of the unearned portion of such prepaid finance charge in an amount not less than the amount that would be calculated by the actuarial method, provided that Mortgagor shall not be entitled to any refund of less than \$1.00. For the purposes of this paragraph the term "actuarial method" shall mean the method of allocating payments made on a debt between the outstanding balance of the obligation and the precomputed finance charge pursuant to which a payment is applied first to the accrued precomputed finance charge and any remainder is subtracted from, or any deficiency is added to the outstanding balance of the obligation.

- 3. Charges; Liens. Mortgagor shall per of calle to be pild all lanes, sales ments, and other charges, fines, and impositions attributable to the Property that may attain a priority over this Mortgage, leasehold payments or ground rents, if any, and all payments due under any mortgage disclosed by the title insurance policy insuring Mortgagee's interest in the Property (the "First Mortgage"), if any. Upon Mortgagee's request, Mortgagor shall promptly furnish to Mortgagor shall promptly discharge any lien that has priority over this Mortgagor shall promptly discharge any lien that has priority over this Mortgage, except the lien of the First Mortgage; provided, that Mortgagor shall not be required to discharge any such lien so long as Mortgagor shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Mortgagee, or shall in good faith contest such lien by, or delend enforcement of such lien in, legal proceedings that operate to prevent the enforcement of the lien or forfeiture of the Property or any part thereof.

Mortgagor shall promptly out his to Mortgagee all renewal notices and all receipts for paid premiums. In the vent of loss, Mortgagor shall give prompt notice to the insurance carrier and Mortgage. Mortgagee may make proof of loss if not made promptly by Mortgago.

Unless Mortgagee and Mortgagor otherwise agree in writing incurance proceeds shall be applied to restoration or repair of the Property tan anid, provided such restoration or repair is economically feasible and the security of this Mortgage is not thereby impaired. Mortgagee shall not be required to commence proceedings again and such successor or refuse to extend time for payment or otherwise modify by reasen of any demand made by the original Mortgagor and Mortgagor's successor, in interest.

Any for ehearance by Mortgagee in exercising any right or remedy under the Agreement, hereunder, or otherwise afforded by applicable law, shall not be a waiver of or preclude the exercise of any such right or real y. The procurement of insurance or the payment of taxes or other liens or charge 4 by h fortgagee shall not be a waiver of Mortgagee's right to accelerate the maturity. - 11. Successors and Assigns Bound; Join, and Several Liability; Captions. The covenants and agreements herein or lined shall bind, and the rights hereunder shall inure to, the respective successors and assigns of Mortgagee and Mortgagor, subject to the provisions of paragraph 16 hereof. All covenants and agreements of Mortgagor shall be joint and several. The captions and headings of the paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define the provisions hereof.
- 12. Legislation Affecting Mortgagee's Rights. Itenactment or expiration of applicable laws has the effect of rendering any provision of the Agreement or this Mortgage unenforceable according to its terms, Mortgagee, at its option, may require immediate payment in full of all sums accured by this Mortgage and may invoke any remedies permitted by paragraph 19.
- 13. Notice. Except for any notice required under applicable law to be given in another manner, (a) any notice to Mortgagor provided for in this Mortgago shall be given by mailing such notice by certified mail addressed to Mortgagor at the Property Address or at such other address as Mortgagor may designate by notice to Mortgagoe as provided herein, and (b) any notice to Mortgagoe shall be given by certified mail, return receipt requested, to Mortgagoe's address stated herein or to such other address as Mortgagoe may designate by notice to Mortgagor as provided hereis. Any notice provided for in this Mortgagos shall be doesned to have been given to Mortgagor or Mortgagos when given in the

anner designated herein. 14. Governing Law, Severability, This Mortgage shall be governed by the laws of Illinois. In the event that any provision or clause of this Mortgage or the Agreement conflicts with applicable laws, such conflict shall not affect other provisions of this Mortgage or the Agreement which can be given effect without the conflicting provision, and to this end the provisions of this Mortgage and the Agreement are declared to be severable; provided that Mortgagee may exercise its termination option provided in paragraph 12 in the event of changes in law after the date of this Mortgage.

- 15. Mortgagor's Copy. Mortgagor shall be furnished a conformed copy of the Agreement and of this Mortgage at the time of execution or after recordation hereof.
- 16. Transfer of the Property; Assumption. To the extent permitted by law, if all or any part of the Property or an interest therein, including without limitation any part of any beneficial interest in any trust holding title to the Property, is sold or transferred by Mortgagor without Mortgagee's prior written consent, Morigagee may, at Morigagee's option, declare all the sums secured by this Mortgage to be immediately due and payable.
- 17. Revolving Credit Lora. This Mortgage is given to secure a revolving credit loan unless and until such lorge is converted to an installment loan (as provided in the Agreement), and shall share not only presently existing indebtedness under the Agreement but also fifter advances, whether such advances are obligatory or to be made at the option of Fortgagee, or otherwise, as are made within 20 years from the date hereof, to the same extent as if such future advances were made on the date of the execution of this Mortgage, although there may be no advance made at the time of execution of this Mortgage and although there may be no indebtedness secured hereby cutstanding at the time any advance is made. The lien of this Mortgage shall be valid as to all indebtedness secured hereby, including future advances, from the time of its filing for record in the recorder's or registrar's office of the county in which the Property is located. 20. Assignment of Rents; Appointment of Receiver; Morigagee in Possession. As additional security hereunder, Mortgagor hereby assigns to Mortgagee the rents of the Property, provided that Mortgagor shall, prior to acceleration under paragraph 19 hereof or abandonment of the Property, have the right to collect and retain such rents as they become due and payable.

Upon acceleration under paragraph 19 hereof or abandonment of the Property, and at any time prior to judicial sale, Mortgagee, in person, by agent, or by judicially appointed receiver, shall be entitled to enter upon, take possession of and manage the Property and to collect the rents of the Property including those past due. All rents collected by Mortgagee or the receiver shall be applied first to payment of the costs of management of the Property and collection of rents including, but not limited to receiver's fees, premiums on receiver's bonds, and reasonable attorneys' fees, and then to the sums accured by this Mortgage. Mortgagee and the receiver shall be liable to account only for those rents actually received.
