SPECIAL LIMITED POWER OF ATTORNEY

To execute on behalf of the institutions listed in Exhibit 8 by and through the RTC acting in its capacity as conservator or receiver of said institutions: (i) any and all satisfactions of mortgages or lien transfers and reconveyances of deeds of trust for the purpose of completing satisfactions due to payoffs; and (ii) any and all mortgage noce endorsements, assignments of mortgage, deeds of trust or related documents, assignments, terminations or continuations of U.C.C. Formal Financing Statements, assignments or reassignments of rents, leases and profits, and special warranty deeds for the purpose of facilitating the efficient discharge of duties outlined in certain fooling and Servicing Agreements referenced in Exhibit C attached hereto and made a part hereof (the "Agreements"). All documents referenced herein shall be executed pursuant to the authority and procedures detailed in the Agreements.

This Special Limited Power of Attorney shall be effective as of September 1, 1992 and shall continue through and including September 30, 1993.
