Changes to the per annum rate of interest, as described above, shall be subject to the following limitations: a) The interest rate shall never be changed by more than 2.00% from the interest rate which was in effect immediately prior to such change and b) The interest rate payable at any time during the term of the loan shall never be mater than 13.00% or lower than 8.00% per annum. Late charges and default charges as specified below, however, are payable in addition to the per annum rate limitations set forth in this paragraph and nothing contained herein shall be dismed to limit the imposition of such late charges and/or default charges.

The initial monthly installment payments of principal and interest shall be in an amount necessary to amortize the original indexternoss, together with interest at the initial rate, over a Twenty Five year period (the Amortization Period).
