6. DEFAULT AND REMEDIES. Upon default in the payment of, or in the performance of, any of the Obligations. Lender may at its option tales possession of the real property and the improvements and have, hold, manage, lease and operate the Premises on remains and for a period of time the Lender deems proper.
