

Sec. 6321, Lien For Taxes

Sec. 6322. Period Of Lien.

Liniose another date is apecifically fixed by law, the lien imposed by section \$333 similaries at the time the essentiment is made and shall continue until the liability for the smouth to assessed (or a judgment against the laxipayer arising out of such Fability) is satisfied or becomes unanforceable by reason of lepse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security interests, Mechanic's Lienors, And Judament Lien Creditors. - The Hen Imposad by section 5321 shall not be valid as applies any purchaser, holder of a security interest, reschanic's lienar, or judg-ment iten creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary.
