

### Excerpts From Internal Revenue Code

# Sec. 6321. Lien For Taxes

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount (including any interest. and and are common, the emoting the company of interest additional amount, addition to tax, or asser sability penalty, together with any costs that may accrue in a different shall be a feen in favor of the United States upon all property and rights to property, whether real or personal, but and to such person

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the lies imposed by section \$327 \$triff arise at the time the essessment is made and shall continue until the liability for the immount on absolute (or is judgment against the tempayer arteing out of such liability) is settlefted or becomes unenforce able by reason of lapse of time.

# Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors.—The Bent Imposed by Section \$021 shall not be valid as against any purchaser, holder of a security interest, mechanic's item, or judgment lien creditor; until notice thereof which means the requirentilien creditor until natios thereof which meets the require into of subsection (f) has been filed by the Secretary.

#### m Place For Filling Notice; Form.-

(1) Place For Filing - The notice referred to in sub-section (a) shall be filed-(A) Under State Laws

(i) Real Property - in the case of real property, in one office within the State (or the county, or other povernmental aubdivision), as designated by the laws of such State, in which the property subject to the Ken is situtated; and

(II) Personal Property-In the case of personal property, whether langible or intengible, in one office property, whether langible or intangible, in one office within pige State or procurry, or other genericalized aubdivision), as designated by the laws of such State, in which the property subject to the lien is altuated; except that State law merely conforming to restructing Program law establishing it neglorist fling system dose not constitute a second office for filing as designated by the laws of such State; or (B) With Clerk Of District Court-in the office of the law limited States district court for the ladded eigentes.

(B) With Clerk Of District Court-in the office of the clerk of the United States district court for the judicial cistriot in which the property subject to lien is situated, whenever the State has not by law designated one office which meets the requirements of subparagraph (A), or (C) With Recorder Of Deeds Of The District Of Columbia - In the office of the Recorder of Diseas of the District of Columbia, if the property subject to the lien is situated in the District of Columbia.
