

Excerpts From Internal Revenue Code

Sec. 6321. Lien For Texes

If any person liable to pay any tax neglocis or refuses to pay the same after demand, the amount (including any interest) additional amount. Eddition to tax, or asses with penalty tigather with any costs that may accuse in so victor, theretay shall be a lien in favor of the United States upon (4) property and rights to properly, whether real or personal, believing to such person.

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the lien imposed by section 8323 shall arise at the time the seeperment is made and shall continue until the flability for the amount so assessed (or a judgment against the jaxpayer arising out of such liability) to satisfied or becomes unenforce-able by reason of lapse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

Interests, Mechanic's Lienors, And Judgment Lien Creditors: The first Imposad by section 5321 shall not be velid as against any purchase or, holder of a security interest, mechanic's lienor, or judgment hen creditor until notice thereof which meets the requirements of subsection (f) has been tiled by the Secretary.
