SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR THE TOWNE PARK CONDOMINIUM ASSOCIATION 93760774

This Second Amendment ("Second Amendment") to that certain Declaration of Condominium Ownership and of Easements. Restrictions, Covenants and By-Laws for The Towne Park Condominium Association dated November 18, 1992 and recorded with the Recorder of Deeds of Cook County, Illinois (the "Recorder") on November 18, 1992 as Document No. 92867813 (the "Declaration"), as amended by that certain First Amendment to Declaration dated April 5, 1993, and recorded with the Recorder on April 29, 1993 as Document No. 93319540 (the "First Amendment"; the Declaration and the First Amendment are collectively referred to hereafter as the "Declaration") is made and entered into by and between RJB-" Limited Partnership, an Illinois limited partnership (hereafter referred to as the "Declarant") and M. Patricia Kane (hereafter referred to as "Kane"):

WHEREAS, the real estate described on Exhibit A of the Declaration (the "Property"), located in the County of Cook and State of Illinois, has been submitted to the Condominium Property Act of the State of Illinois (the "Act") pursuant to the Declaration; and

WHEREAS, Kane is the Unit Owner of Unit 2C in the Condominium legally described on Exhibit A attached to and made a part of this Second Amendment; and

WHEREAS, The Declarant is the successor to the Declarant as set forth in the Declaration and is the Unit Owner of Unit 2D, and the owner of Parking Space 5, which is a Limited Common Element to Unit 2D; and

WHEREAS, Unit Owners may transfer Limited Common Elemen's and the Exclusive Parking Use to specific Parking Spaces between themselves pursuant to Sections 3.4 and 4.12 of the Declaration and Section 26 of the Act; and

WHEREAS, Declarant desires to transfer the Exclusive Parking Use to Parking Space 5 to Kane.

NOW, THEREFORE, Declarant and Kane, for the purposes above set forth, hereby declare that the Declaration is amended as follows:

- 1. The Exclusive Parking Use to Parking Space 5 is hereby transferred from Declarant to Kane and Parking Space 5 shall be a Limited Common Element appurtunent, and is hereby assigned, to Unit 2C.
- 2. The Declarant and Kane hereby state that no changes in the undivided ownership in the Common Elements of any Unit are made by the transfer effected by this Second Amendment, and that no other Unit Owners have any right to use the Limited Common Elements affected by this Second Amendment.
- 3. Except as herein specifically amended, the Declaration is ratified and confirmed in its entirety.
