THE COVENANTS, CONDITIONS HOVISIONS REFERRED TO ON FAGE 4 THE REVERSE SIDE OF THIS TRUST DEED):

1. Mortoagora shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed, (b) keep said premises in good condition and repair, without waste, and free from mechanics or other lens or dialms for lens not expressly subordinated to the lien hereof; (c) pay when due any indebtedness which may be abound by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satelactory evidence of the discharge of such prier lien to Truetce or to Holders of the Note, (d) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises, (e) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (f) make no material alterations in said premises except as required by law or municipal ordinances.

2. Mortoagors shall pay before any penalty attaches all peneral taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, turnish to Trustee or to Holders of the Note duplicato receipts thorefor. To prevent default hereunder Mortoagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortoagors may desire to contest.
