THIS MORTGAGE ("Mortgage") is made this 17TH day of SEPTEMBER 1993 between Mortgagor,  
SUSAN B. KEENER, UNMARRIED A/K/A SUSAN KEENER, UNMARRIED

(herein "You," "Your" or "Yours") and the Mortgagee, Citibank, Federal Savings Bank, a corporation organized and existing under the laws of the United States, whose address is 870 Mason Ridge Center Drive, St. Louis, Missouri 63141) herein "We," "Us" or "Our".

WHEREAS, SUSAN B. KEENER

Together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water rights and stock and all fixtures now or hereafter a part of the property. All replacements and additions shall also be covered by this Mortgage. All of the foregoing is referred to in this Mortgage as the "property".

You covenant that you are lawfully seized of the estate hereby conveyed and have the right to mortgage, grant and convey the property and that the property is unencumbered, except for encumbrances of record. The insurance carrier providing the insurance shall be chosen by you subject to our approval which shall not be unreasonably withheld.
