Lawhead and Rita B. Lawhead, as purchasers, in which they agreed to pay the sum of Sixteen Thousand Two Hundred Dollars (\$16,200.00) to the order of W. J. Driver, Administrator of Veterans' Affairs of the U.S.A. for the purchase of the real estate described hereinabove. Further, that the title to said real estate was conveyed to Robert G. Kudlo and Adeline M. Kudlo, husband and wife, as tenants by the entireties, by deed of conveyance dated September 23, 1992, and recorded in the Office of the Cook County Recorder.

That the marital relationship which existed between the affiant and Adeline M. Kudlo, his wife, continued unbroken from the time they so acquired their interest in the Contract until the death of Adeline M. Kudlo on the 25th day of November, 1991, at which time this affiant acquired title to the real estate as surviving tenant by the entireties.

That the gross value of the estate of the decedent, Adeline M. Kudlo, as determined for the purpose of Federal Estate Taxes, was less than the value required for the filing and the decedent's estate was not subject to Federal Estate Tax. Further, all other taxes, of whatever type required, have been paid.


