As of the date hereof, the said debtors were the owners of the following land, to wit:

Unit No. 208-H, as delineated on the survey of the following described real estate (hereinafter referred to as "Parcel"): That part of the Southeast Quarter of Fractional Section 10, Township 41 North, Range 12 East of the Third Principal Meridian, described as follows: Commencing at the Southeast corner of the aforesaid Southeast Quarter of Section 10; thence North 335.57 feet along the East line of said Southeast Quarter; thence West 639.99 feet along a line drawn perpendicular to the East line of said Southeast Quarter, to the point of beginning of the herein described tract of land; thence continuing West 179.94 feet along the Westerly extension of said perpendicular line; thence North 73.48 feet along a line drawn parallel with the East line of the aforesaid Southeast Quarter; thence East 179.94 feet along a line drawn perpendicular to the East line of the aforesaid Southeast Quarter; thence South 73.48 feet along a line drawn parallel with the East line of the aforesaid Southeast Quarter, to the hereinabove designated point of beginning, in Cook County, Illinois, which survey is attached as Exhibit "B" to the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for Courtland Square Condominium Building No. 31 made by Harris Trust and Savings Bank, as Trustee under Trust Agreement dated February 28, 1979 and known as Trust No. 39321, and recorded in the Office of Cook County Recorder of Deeds as Document No. 25053463, together with an undivided 7.646048% interest in said Parcel (excepting from said Parcel all the units thereof as defined and set forth in said Declaration of Condominium Ownership and survey
