TERMINATION OF GROUND LEASE FOR 3600 E. 95TH STREET Chicago, Illinois

This instrument made as of this 31stday of December, 1989, by and between the ILLINOIS INTERNATIONAL PORT DISTRICT, an Illinois municipal corporation, formerly known as the CHICAGO REGIONAL PORT DISTRICT ("Landlord") and CERES TERMINALS INCORPORATED, an Illinois corporation ("Tenant").

WITNESSETH

WHEREAS, Landlord did lease to Tenant the real property described on Exhibit A attached hereto (the 'Premises") pursuant to the terms of that certain Ground Lease dated November 15, 1984, as supplemented by a certain Agreement dated November 15, 1984, and amended by a certain Modification to Lease and Memorandum of Lease dated March 20, 1985 and a certain Amendment to Ground Lease dated April 23, 1985 (collectively "Lease"); and

WHEREAS, the parties here to desire to terminate the Lease in consideration of the Landlord's agreement to extend the terms of Tenant's two warehouse leases at Iroquois Landing;

NOW THEREFORE, in and for consideration of the mutual covenants set forth herein, and other considerations exchanged among the parties, the receipt and sufficiency of which is hereby acknowledged, the parties do hereby agree as indows:

- 1. The term of the Lease as set forth in Section 201 of the Lease shall end December 31, 1989 (the "Termination Date").
- 2. Under Section 303 of the Lease, the improvements on the Premises become the absolute property of Landlord as of December 31, 1989.
- 3. Tenant shall convey by recordable quit claim deed, all of its rights, title and interest in the Premises, and the improvements constructed thereon to Landlord as of December 31, 1989.
- 4. All of Tenant's rights, title and interest in the Premises and the improvements constructed thereon shall terminate as of December 31, 1989, however, Tenant's obligation to defend and indemnify Landlord for acts or omissions occurring prior to December 31, 1989 shall survive and continue as set forth in Section 2101 of the Lease.
