LOAN MODIFICATION AGREEMENT

WHEREAS FIRST FEDERAL BANK FOR SAVINGS, FORMERLY KNOWN AS, FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF DES PLAINES ("Lender"), whose address is 749 Leo Street, Dos Plaines, IL, loaned to Joseph Pellegrino and Jo Ann J. Pellegrino, 214 S. Helena Ave., Arlington Heights, IL 60006 ("Borrower" and collectively known as "Partien") the num of Thirty seven thousand and 00/100 Dollara (\$37,000.00), secured by the real estate described in Exhibit A attached and made a part bereof, and evidenced by a Note and Mortgage executed and delivered on, April 12, 1991, which mortgage was duly recorded on April 12, 1991 as Document Number 3957192, in the Office of the Cook County Registrar of Titles, and which Note and Mortgage are hereby incorporated barein as a part of this instrument, and;

WHEREAS, the Borrower has requested that certain modifications be made in the Note and Mortgage, and:

WHEREAS, broower represents to Lender that there are no encumbrances evidencing other indebtedness other shase quent liens (second mortgages) now outstanding against the mortgaged premises, except those half by Lander, and the lien of the Lender's Mortgage, as modified, is a valid lien, and;

WHEREAS, the Borrower has requested certain modifications of the said Note and Mortgage; THEREFORE, for good and valuable consideration, the parties do mutually agree that the Note and Mortgage are modified as follows:

interest Rate: The interest rate of the Note is changed to 6.50% per annum, said rate change to take effect on the 1st day of October 1993. This rate shall remain fixed throughout the remaining term of the loan.

Principal Balance: The unpaid balance of the rote including any financed points is Thirty five thousand fifty one and 81/100 Dollars (\$35,057,81). In consideration of this loan modification agreement, discount points in the amount of \$552.52 were paid.

Maturity Date: The maturity date of the note is modified by this agreement. The maturity date is October 1, 2008.

Principal & Interest Payment: Borrower agrees to pay principal Falance with interest at the above stated rate in monthly payments of Three hundred five and 37,100 Dollars (\$305.34).

Payment Due Date: The above payment amount shall be due monthly beginning on the 1st day of November 1993 and on the 1st of each month thereafter until above Note is fully paid, but no later than October 1, 2008.

Borrower coverants and agrees to pay the balance of the indebtedness evidence? By the Note and secured by the Mortgage as modified, and to perform the covenants contained in the Mortgage. Borrower further agrees that the prepayment privilege now in effect shall remain in full force and effect. Borrower represents to Lender that there is no second mortgage or other subsequent lien now outstanding against the Mortgaged Premises held by the Lender, except as otherwise disclosed in this Agreement, and that the lien of the Mortgage is a valid, first and subsisting lien on the Mortgaged Premises.

The parties acknowledge and agree that no liability whatsoever is admitted on the part of any party, except Borrower's indebtedness to Lender under the Note and Mortgage, and that all agreements and understandings between Borrower and Lender are expressed and embodied in the Note and Mortgage, as modified by this Agreement.
