was/were the owner(s) of the legally described property which is also commonly known as 1919 N EASTWOOD Arlington Heights, Illinois, and received and benefitted from water service from the Village of Arlington Heights, and continued to receive benefit through the use of said water through 5/1/93 and incurred a total charge of \$ 3067.89 from the Village of Arlington Heights, which became due and owing on 5/21/93 by virtue account statements rendered on or before said date; and twenty-one (21) days after said due and owing date, a penalty in an amount equal to ten percent (10%) of said amount was added as a penalty for failure to make prompt payment for a total sum of \$3374.68 and twenty-one (21) days thereafter, to wit on 6/10/93 said account became delinquent, in accordance with the ordinance of the Village of Arlington Heights.
