THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS Trust Deed):

- 1. Grantors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed, (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien hereof, (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to Beneficiary, (4) complete within a reasonable time any buildings how or at any time in privaces of erection upon said premises, (3) comply with all requirements of law or municipal ordinances with respect to the premises and the use theroof; (6) make no material alterations in said premises except as required by law or municipal ordinance.
- 2. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in including attorney's fees, and any other moneys advanced by Touce or Beneficiary to protect the mortgaged premises and the lien hereof, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and wiff oner at theiron in the annual percentage rate stated in the Lawn Agreement this Trust Deed secures. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of Grantors as the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such receiver shall have the power to collect the remis, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency, during the full set alony, errord of rederaption, whether there he redemption or not, as well as during any further times when Grantors, except for the intervention of such receiver, would be entitled to collect such rents, it uses and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said period. Trustee has no duty to examine the title, location, existence, or condition of the premises, nor shall frustoe in chigated to record this frust Deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for any acts or comissions hereunder, except in case of gross negligible or misconduct and Trustee may require indemnities satisfactory to Trustee before exercising any power herein given.
- 13. Upon presentation of satisfactory evidence that all indebtedness recurred by this Trust Deed has been fully paid, either before or after maturity, the Trustee shall have full authority to release this Trust Deed, the lien thereof, by proper instrument
- 14. In case of the resignation, inability or refusal to act of Trustee, the Beneficiary shall have the authority to appoint a Succession of Trust. Any Successor in Trust hereunder shall have the identical title, powers and authority as are herein given Trustee.
- 15. This Trust Deed and all provisions hereof, shall extend to and be binding upon Grantors and all persons claiming under or through Grantors, rold the word "Grantors" when used herein shall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed be Loan Agreement or this Trust Deed.
