(b) Pursuant to Section 3-3 of the Corporate Fiduciary Act, title under the respective Land Trusts to the real estate held by the Former Trustee was vested by law in the Successor Trustee as of the date of this Appointment and Voluntary Instrument.

(a) Pursuant to the Agreement, the Former Trustee has appointed the Successor Trustee as trustee, in place of the Former Trustee, of the Land Trusts, as of the date of this Appointment and Voluntary Instrument.

Section 3. *Recitals.* The following recitals of fact are a material part of this Appointment and Voluntary Instrument:

"Voluntary instrument" means any document, instrument, or paper that either conveys the fee title to registered land or affects title to registered land and the validity of which is dependent upon consent by an owner of the registered land or some person claiming by, through, or under that owner. Voluntary instruments include, but are not limited to, deeds, including tax deeds, sheriff's deeds, and marshal's deeds, mortgages, assignments of mortgages, leases, and grants of easement or license.

"Torrens Repeal Law" means the Torrens Repeal Law, 765 ILCS 40.

"Successor Trustee" means Cole Taylor Bank, an Illinois banking corporation, whose address is 850 W. Jackson Street, Chicago, Illinois 60607, as successor trustee under the Land Trusts.

"Land Trusts" means those Illinois land trusts, as such are defined in the Illinois Land Trust Recordation and Transfer Tax Act, 765 ILCS 42/2, identified by trust number and Certificate of Title number on Exhibit A, pursuant to which the Former Trustee held title to the real estate described on the Certificates of Title and the Registrar's Certifications of Condition of Title.

"Registrar's Certification of Condition of Title" means a Registrar's certification of condition of title, as defined in Section 2 of the Torrens Repeal Law, which provides as follows: "Registrar's certification of condition of title" means a document, prepared manually or by data processing equipment, that contains the number of the certificate of title, name of the owner, permanent real estate index number, legal description of the land, and nature of the estate of the owner and by *recital* contains a description of all estates, easements, encumbrances, liens, interests, and charges to which the estate of the owner is subject in the event title to the nature and character of the condition or limitation, it shall state the

The term "including" or variants thereof shall mean "including without limitation".

"Former Trustee" means Harris Trust and Savings Bank, an Illinois banking corporation attention Robert E. Mausser, Vice President, Personal Financial Services Department, whose address is 111 W. Monroe Street, Chicago, Illinois 60603, as trustee under the Land Trusts.

"Corporate Fiduciary Act" means the Corporate Fiduciary Act, 205 ILCS 620.

"Certificate of Title" means a current certificate of title identified in Exhibit A to this Appointment and Voluntary Instrument.

"Appointment and Voluntary Instrument" means this declaration of appointment of successor in trust and Voluntary Instrument.

"Agreement" means the purchase and trust succession agreement dated as of August 16, 1993 between the Former Trustee, as seller, and the Successor Trustee, as purchaser, in respect to a portion of the trust business of the Former Trustee, including its trusteeship under the Land Trusts.

Section 2. *Definitions.* The following capitalized terms have the respective meanings defined in Exhibit A to this Appointment and Voluntary Instrument is hereby incorporated by reference.
