## MODIFICATION AGREEMENT

Whereas, Bank of Northern Illinois is the holder of a certain note in the amount of \$230,130.26 secured by a Mortgage or Trust Deed dated June 10, 1986, recorded in the Office of Recorder of Cook County, Illinois, as document No. 86243341 regarding the real estate commonly known as 2200 Waukegan Road, Glenview, IL 60025 and legally described as follows:

Now Therefore, for and in consideration of the mutual covenants and conditions hereinafter set forth and the amount of \$1.00 (one dollar) paid by each party to the other, the receipt and sufficiency of which is hereby acknowledged, it is agreed as follows:

1. The maturity date under the aforesaid Note and as referred to in the aforesaid mortgage or Trust Deed is hereby modified to be December 31, 1993.
2. That each and every other term of the aforementioned Note and Mortgage or Trust Deed is hereby satisfied and reaffirmed and shall be deemed to constitute the agreement of the parties .
