- (a) One-twillfth of the estimated yearly taxes and assessments on the Property which under the applicable law may be superior to this Security Instrument; plus

- (c) One-twelfth of the estimated yearly premium for hazard insurance covering the Property; plus
- (d) One-twelfth of the estimated yearly premium for mortgage insurance, if any.

I will give Leitder all notices or bills that I receive for the amounts due under this Paragraph 2.

(II) Lender's Obligations

If I make my payments to Lender, Lender will satimate from time to time my yearly taxes, hazard insurance premiums, assessments, lessehold payments, ground rents and mortgage insurance premiums, which items will be called the "Escrow items." When I have paid all of the amounts due under the Secured Notes and under this Security instrument, Lendar will promptly refund to me any Funds that are then being held by Lendar. Any claim, defined or charge it as is need against properly because an obligation has not been fulfilled is nown as a liter. Will promptly pay or satisty all liens against the Property that may be superior to this Security Instrument. However, this Security Instrument does not require me to satisfy a superior lien if; (A) I agree, in writing, to pay the obligation which gave rise to the superior lien and Lender approves in writing the way in which I agree to pay that obligation; or (B) in good faith, I argue or defend against the superior lien in a iswault so that, during the iswault, the superior lien may not be enforced and no part of the Property must be given up; or (C) I secure from the holder of that other lien an agreement, approved in writing by Lender, that the lien of this Security instrument is superior to the lien held by that Person, If Lender determines that any part of the Property is subject to a superior lien, Lender may give to me a notice identifying the superior lien. I will pay or satisfy the superior lien or take one or more of the actions set forth above within 10 days of the giving of notice.

5. BORROWER'S OBLIGATION TO MAINTAIN INSURANCE

At my sole cost and expense, I will obtain and maintain hazard insurance to cover all buildings and other improvements that now are or in the future will be located on the Property. The insurance must cover loss or damage caused by fire, hazards normally covered by "extended coverage" hazard insurance policies and other hazards for which Lander requires coverage. The insurance must be in the amounts and for the periods of time required by Lender, I may choose the insurance company but my choice is subject to Lender's approval. Lender may not refuse to approve my choice unless the refusal is reasonable. All of these insurance policies and renewals of the policies must include what is known as a Standard Mortgages Offices to protect Lender. The form of all policies and renewals must be acceptable to Lunder, Lender will have the right to hold the policies and renewals. If Lender requires, I will promptly give Lender all receipts of paid premiums and renewal notices that I receipts.

If I obtain earthquake insurance, any other hazard insurance, credit life and/or disability insurance, or any other insurance on or relating to the Property or the Secured Notes and which are not specifically equired by Lander, I will name Lender as loss payee of any proceeds.

If there is a loss or damage to the Property, I will promptly notify the proper insurance company and Lender. I I do not promptly prove to the insurance company that the loss or damage occurred, then Lender may do so.

The amount paid by the insurance company is called "Proceeds." Any Proceeds received will be applied first to reimburse Lender, for costs and expenses incurred in connection with obtaining the Proceeds, and then, at Lender's option and in the order and proportion as Lender may determine in its sole and absolute discretion, regardless of any impairment or tack of impairment of security, as follows: (A) to the extent allowed by applicable law, to the Sums Secured in a manner that Lender determines and/or (B) to the payment of costs and expenses of necessary repairs or to the restoration of the Property to a condition satisfactory to Lender, such application to be made in the manner and of the times as determined by Lender.

If I abandon the Property or If I do not answer within 30 days, a notice from Lender stating that the Insurance company has offered to settle a cisim, Lender may collect the Proceeds, Lender may use the Proceeds to repair or restole the Property or to pay the Sums Scoured. The 30-day period will begin when the notice is given

If any Proceeds are used to reduce the amount of principal which I owe to Lendar under the Secured Notes, that use will not delay the due date or change the amount of any of my monthly payments under the Secured Notes and under Puramephs 1 and 2 above. However, Lendar and I may agree in writing to delays or changes.

If Lander acquires the Property under Paragraph 27 below, all of my rights in the Insurance policies will belong to Lender. Also, all of my rights in any proceeds which are paid because of damage that occurred before the Property is acquired by Lender or sold will belong to Lender. However, Lender's rights in those proceeds will not be greater than the Sums Secured immediately before the Property is acquired by Lender or sold.

If I am required by Lender to pay premiums for mortgage insurence, I will pay the premiums until the requirement for mortgage insurance ends according to my written agreement with Lender or according to law.

7. LENDER'S RIGHT TO PROJECTIS RIGHTS IN THE PROPIET.

It: (A) I do not keep my promises and agreements made in this security instrument, or

(B) someone, including me, begins a legal proceeding that may significantly affect Lender's rights in the Property (such as a legal proceeding in bankruptcy, in probate, for condemnation or to enforce laws or regulations), then Lender may do and pay for whatever is necessary to protect the Lender's rights in the Property. Lender's actions may include appearing in court, paying reasonable attorneys' fees and entering on the Property to make repairs. Lender must give me notice before Lender may take any of these actions. Although Lender may take action under this Paragraph 7, Lender does not have to do so. Any action taken by Lender under this Paragraph 7, will not release mis from my obligations under this Security instrument.

I will pay to Lender any amounts which Lender advances under this Paragraph 7 with interest, at the interest rate in effect under the Secured Notes which have not been paid, I will pay those amounts to Lender when Lender sends me a notice requesting that I do so. AGREEMENTS ABOUT GOVERNMENTAL TAKING OF THE PROPERTY
