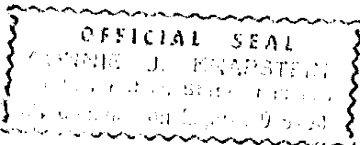

That part of the North East 1/4 of Section 11, Township 28 North, Range 13 East of the Third Principal Meridian, described as follows: Beginning at the point of intersection of the South line of the North 913 feet of said North East 1/4 with the West line of the East 1677.12 feet of said North East 1/4: Thence South along said West line of East 1677.12 feet a distance of 310.90 feet to a point that is 1223.90 feet south of said North line of the North East 1/4 thence Northwesterly on an arc of a circle having a radius of 241.0 feet convex to the South West which terminates at its point of Tangency in the West line of the East 1792.12 feet of said North East 1/4 being 1019.0 feet South of the said North line of the North East 1/4 for a distance of 19.11 feet to a point in the West line of the East 1693 feet of said North East 1/4 for the place of beginning of this tract of land; thence North of said line being on the center line of an existing brick wall and its extension thereof, a distance of 123.10 feet, thence East on the center line of a brick wall, a distance of 0.60 feet being the West line of East 1692.40 feet of said North East 1/4 thence North on the center line of a brick wall, a distance of 20.15 feet thence East on the center line of a brick wall, a distance of 2.08 feet thence North on the center line of a brick wall a distance of 17.50 feet thence West on the center line of a brick wall a distance of 2.08 feet being on the said West line of the East 1692.40 feet being on the center line of a brick wall and its extension a distance of 139.60 feet to a point in the said South line of the North 913.0 feet of said North East 1/4 thence West of said line a distance 99.72 feet to a point in said West line of the East 1792.12 feet of said North East 1/4 thence South on said line a distance of 106.0 feet to the aforesaid point of tangency of the curved line whose radius was 241.0 feet thence Southeasterly on the arc of said curve convex to the South West a distance of 226.86 feet to the place of beginning in Cook county, Illinois.
