THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED):

- 1. Grantors shall (1) promptly repair, restors or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanics or other here or claims for lien not expressly subcritinated to the lien hereal; (3) pay when due any indebtedness which may be secured by a lien or charge of the hereal; and the premise sind upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to Beneficiary; (4) complete within a reasonable time any buildings now or at any time in process of section upon said premises; (6) make no material alterations in said premises except as required by law or municipal ordinance.
