EXTENSION AGREEMENT

THIS AGREEMENT made this 16th day of August, 1993, between THE STEEL CITY NATIONAL BANK OF CHICAGO, a national banking association, hereinafter called First Party, and HECTOR M. HUNT, the present owner of the subject property and/or obligor under the Note, hereinafter called Second Party, WITNESSETH:

THAT, WHEREAS, First Party is the owner of that certain Note in the amount of ONE MILLION ONE HUNDRED FIFTY THOUSAND AND NO/DOLLARS (\$1,150,000.00), secured by a Mortgage dated August 11, 1988, and recorded in the Cook County Recorder's Office on August 16, 1988 as document Nos. 88-371595 and 88-371616, and filed in the Office of the Registrar of Titles as document No. LR3731917, encumbering the real estate described as follows:

AND, WHEREAS, the parties hereto have previously modified the terms of said Note and Mortgage by increasing the principal amount thereof, by changing the interest rate charged under the Note to 10% per annum, by decreasing the amount of monthly installments of principal and interest to \$11,764.36, and by extending the maturity thereof to August 16, 1993.

AND, WHEREAS, the parties hereto wish to further modify the terms of said Note and Mortgage by extending the maturity thereof to February 15, 1994.

NOW THEREFORE, in consideration of ONE DOLLAR, the covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. As of the date hereof, the outstanding principal amount due under the Note is \$1,127,595.75.

2. The maturity date of the Note and Mortgage hereinbefore described is hereby extended from August 16, 1993 to February 15, 1994.

3. The amount of monthly installments of principal and interest shall remain at \$11,764.36, beginning September 15, 1993 and continuing on the 15th day of each month thereafter until the entire amount due is paid, except that all sums due, if not sooner paid, shall be due and payable on February 15, 1994.

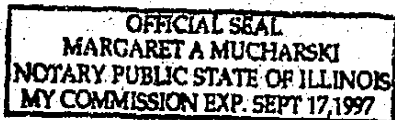
