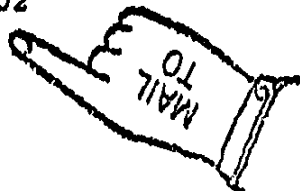

Lots 1, 2, 3 and 39 through 41 inclusive and that part of the vacated north-south alley adjoining said Lots 2 and 39 recorded October 13, 1973 as Document #22500393, of block one in Greater Calumet, subdivision of the North 1/2 of the West 1/2 of the West 1/2 of the West 1/2 of the Northwest 1/4 of Section 32, Township 2 North, Range 14 East of the third principal meridian according to the plat thereon recorded July 6, 1925 as Document Number 8966278.

Except that part of Lots 1 and 39 through 41 inclusive lying Northerly of a line extending from a point in the West Line of said Lot 1, 15.37 Feet South of the Northwest Corner thereof to the east line of said Lot 41, 7.5 Feet South of the Northeast Corner thereof.
