 - Effective as of the date of this Modification, the new maturity date shall by September 1. (c)
- Modification of Mortgage and Loan Documents. The Mortgage, and the Loan Documents are hereby modified and amended in the following respects:
 - Any reference in the Mortgage and other Loan Documents to the stated maturity date (a) shall henceforth mean the modified maturity date of September 1, 1994.
