ORDINANCE NO. 1222-12

AN ORDINANCE APPROVING THE RESUBDIVISION
OF THE SPEHN PROPERTY AT 122ND & SOUTHWEST HIGHWAY

WHEREAS, a petition has been filed with the Village of Palos Park, Cook County, Illinois requesting that certain land, hereinafter described, be resubdivided; and,

WHEREAS, the Plan Commission of the Village of Palos Park has held a public hearing relative to said request and recommended approval of said subdivision; and

WHEREAS, the corporate authorities of the Village of Palos Park deem it to be in the best interests of the Village that said resubdivision be authorized and allowed.

NOW, THEREFORE, BE ORDAINED BY THE VILLAGE COUNCIL of the Village of Palos Park, Cook County, Illinois:

1. The Spehn's Subdivision legally described as follows:

That part of Lot 4, Joseph A. Varon's Second Addition to Palos Dells together with that part of Lot 5, E.W. Lagers Subdivision of the line described as beginning at a point on the North line of said Lots that is situated 310.00 feet West of the Northeast corner of said Lot 5; thence Southeasterly a distance of 199.30 feet; more or less to a point on the Southeasterly line of said Lot 4 that is situated 315.00 feet Southwesterly from the Southeast corner of said Lot 4, all in Township 37 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.
