A. that certain Home Equity Agreement and Disclosure Statement ("Agreement") executed by KATHLEEN MALLOY LEE, DIVORCED AND NOT SINCE REMARRIED ("Borrower"); and

B. the Revolving Credit Mortgage recorded on JULY 23, 1992 as document number 92540127 with the Recorder of Deeds, COOK County, Illinois ("Mortgage") as to the property legally described on Exhibit A attached hereto and commonly known as 1110 RIDGE ROAD, WILMETTE, IL 60091 ("Property")

executed by Borrower or NA as trustee ("Trustee") under Trust Agreement and known as Trust No. NA ("Trust")

The Agreement and Mortgage are each dated as of July 14, 1992.

BANK ONE CHICAGO, NA, AS SUCCESSOR BY MERGER WITH BANK ONE, WILMETTE

Borrower has requested Bank One, Merger with Bank One, Wilmette, Illinois to extend the Maturity as provided for in the Agreement. BANK ONE is willing to agree to such request.

NOW, THEREFORE, for good and valuable consideration, Borrower (and Trust, if applicable) and BANK ONE acknowledge and agree as follows:

1. Borrower does hereby acknowledge and agree that the Agreement is in full force and effect; and that the Property is being occupied as the principal residence of Borrower.

2. Borrower (and Trust, if applicable) do hereby acknowledge and agree that the Mortgage is in full force and effect.

3.  The maximum credit limit rate red to in the Agreement is hereby changed from \$ 40,000.00 to \$ 100,000.00

4.  The Maturity Date is hereby changed from JULY 31, 2002 to October 31, 2003

5. The Mortgage is hereby modified to provide that such instrument and the lien created thereby continues as collateral security for repayment of the obligations due under the Agreement and Mortgage are hereby ratified and reaffirmed.

6. In all other respects, the Agreement and Mortgage are hereby ratified and reaffirmed.

7. In the event the Trust executing this agreement, or any successor trustee, is excused by the Trustee, not personally, but as Trustee aforesaid, in the exercise of the power and authority conferred upon and vested in it as such Trustee and the Borrower hereby warrants that possessors will power and authority to execute this instrument and it is expressly understood and agreed that nothing contained herein or in the Agreement shall be construed as creating any liability on the Trustee personally to the obligations due under the Agreement or Mortgage, or to perform any covenant, either express or implied herein contained, all such liability, if any, being expressly waived by BANK ONE and by every person now or hereafter claiming any right or security hereunder, and that so far as Trustee is personally concerned, the legal holder or holders of the obligations due under the Agreement secured by the Mortgage shall look solely to the Property hereby mortgaged, conveyed and assigned to any other security given at any time to secure the payment thereof.

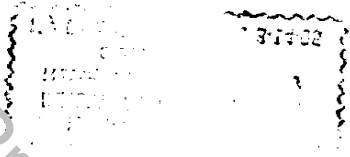
