THIS MORTCAGE made this 30th day of September , 1993 , between Warren W. Farotz and Elvy I. Marotz, his wife and Gregory W. Marotz and Christic M. Wrotz, his wife

(hereinafter refered to as "Mortgager") and River Forest State Bank and Irust Company

DOLLARS (\$ 1,022.02 ) on the first day of each month commencing with October 1 , 1993 with the balance of the indebtedness, if not sooner paid, due and payable on September 1 , 26.23 .

TOGETHER with all the improvements now or hereafter erected on or attached to the Premises, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and all fixtures now or hereafter attached to the Premises, all of which including replacements and additions thereto, shall be deemed to be and romain a part of the Premises covered by this Mortgage and all of the foregoing together with said Premises (or the leasahold estate if the Mortgage is on a leasehold) are herein referred to as the "Premises".

- (d) Complete within a reasonable time any buildings or improvements now or at any time in process of erection upon said Premises.
- (a) Keep said Premises in good condition and repair without waste and free from any mechanics or other lien or claim of lien not expressly subordinated to the lien hereof.
- (f) Not suffer or permit any unlawful use of or any nuisance to exist on said Premises nor to diminish nor impair its value by any act or omission to act.
- (g) Comply with all requirements of law or municipal ordinances with respect to the Premises and the use thereof.
- Comply with the provisions of any lease if this Mortgage is on a leasehold.
- Pay the promiums for any life, disability or other insurance if Mortgagor shall procure contracts of insurance upon his life and disability insurance making the Mortgagoe assigned thereunder. - Any forboarance by Mortgagee in exercising any right or remedy herounder 8. or otherwise afforded by applicable law, shall not be a waiver of or preclude the exercise of any such right or remedy. The procurement of Insurance or the payment of taxes or other liens or charges by Mortgages shall not be a waiver of Mortgages's right to accelerate the indebtedness secured by this Mortgage.
