EXHIBIT "A"

LEGAL DESCRIPTION

Units 2-C and 5-C in Park Tower Condominium as delineated on Plat of Survey of the following described parcel of real estate:

That part of the East fractional half of the northeast 1/4 of Section 8 Township 40 North, Range 14 East of the Third Principal Meridian lying west of the west boundary line of Lincoln park, as established by decree entered July 6, 1905 in Case 285574 Circuit Court, as shown on Plat recorded July 9, 1908 as Document Number 4229498 and south of a line that is drawn at right angles to the east line of Sheridan Road, through a point in said east line that is 1.090 feet south of the north line of said East fractional half of the Northeast 1/4 and north of the following described line: Beginning at a point in said east line of Sheridan Road, that is 1,405.50 feet south of the said north line of the East fractional half of the Northeast 1/4; thence east at right angles to the said east line 208.08 feet; thence north at right angles to the last course, 60 feet; thence east at right angles to the last course 88.01 feet to the said west boundary of Lincoln Park (except the west 47 feet of said East fractional half of the Northeast 1/4 condemned as part of Sheridan Roady all of the above situated in Cook County, Illinois, which plat of survey is attached as Exhibit D to Declaration of condominium recorded as Document 24874698, together with its undivided percentage interest in the common elements in Cook County, Illinois.
