

## Excerpts From Internal Povenue Code

## Sec. 6321. Lien For Taxes

If any person liable to pay any tax neglects or reviews to pay the same after commod, the amount (including any interest additional amount addition to law, or assessable of halfy together with any costs that may accrue in addition thereto, shall be a lien in favor of the United States upon all p op My and rights to property, whether seal or personal, belonging a auch person

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the fier imposed by section 6327 shall arise at the time the about ment is made and shall continue until the liability for the amount so essexted for a judgment against the taxpayer arising out of such like-lifty) is satisfied or becomes unerforceable by reason of Japan of time

Sec. 6323. Validity and Priority Against Cértain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors. - The uen imposed by section 8321 shall not be valid as egainst any purchaser, holder of a security interest, mechanic's lienor, or judgnt tien creater until natice thereof which meets the tequire ments of subsection (f) has been light by the Bestings.
