1. Mortgagor shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for ion not expressly subordinated to the lien hereof; (c) pay when two any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the light hereof; (d) grant hereof; (e) complete within a reasonable time any building or buildings now or at any time in process of efection upon said premises; (e) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (f) make no material alterations in said premises except as required by law or municipal ordinance.

Trustee has no duty to examine the title, location, existence or condition of the premises, or o inquire into the validity of the signatures or the identity, capacity, or authority of the signatures on the note or trust deed, nor shall Trustee be obligated to record this trust deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for any acts or omissions necessary obligated by the terms hereof, nor be liable for any acts or omissions necessary objects or employees of Trustee, and it may require indomnities satisfactory to it before exercising any power
