VERIFIED CLAIM FOR MECHANICS' LIEN



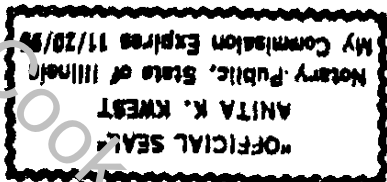

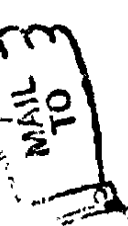
