I, MICHAEL VALLONE, of the City of Elgin, Cook County, Illinois, declare this to be my Will and revoke all of my former Wills and Codicils.

ARTICLE 1: I direct that my debts, expenses of my last illness, iuneral, and the administration of my estate shall be paid by my Executor from the principal of my residuary estate.

ARTICLE II: All inheritance, estate and succession taxes (including interest and penalties thereon) payable by reason of my death, shall be paid out of and be charged generally against the principal of my residuary estate without reimbursement from any person.

ARTICLE III: I bequeath all my persons! and house-hold effects and the like not otherwise effectively disposed of, such as clothing, automobiles (except my Model T Ford antique car), furniture, furnishings, silver, books and pictures (including policies of insurance thereon, if feasible) to my beloved wife, LEANORE H. VALLONE, if she survives me for thirty (30) days.

ARTICLE IV: I give, devise and bequeath the marital home located at 167 Moseley, Elgin, Illinois to my beloved wife, LEANORE H. VALLONE, if she survives me for thirty (30) days and if she does not so survive me, pursuant to Article V of this Will.

A. To my children, MICHAEL VALLONE, JR., currently residing in Lexington, Kentucky, MARYROSE STANLEY, currently residing in Elgin, Illinois, and to my grandaughter, THERESE WARNOCK, currently residing in Crystal Lake, Illinois, if they survive me for thirty (30) days, in equal shares.

B. If either MICHAEL WALLONE, JR. or MARYROSE STANLEY does not survive my for thirty (30) days, that child's share per schrpes; If THERESE WARNOCK does not survive me for thirty (30) days, her share will be divided between MICHAEL VALLONE, JR. and MARYROSE STANLEY, per stirpes.

ARTICLE VI: I appoint my daughter, MARYROSE STANLEY, Executor of this Will, with the following powers, and any others that may be granted by law, to be exercised in her discretion without Court Order, and it is hereby directed that no bond or surety shall be required of her as each Executor:

- To retain any property of my estate;
- estate, for cash or on credit, at public or private sale, for any purpose, to exchange any such property for other property; to grant options to purchase or acquire any such property; and to determine the prices and terms of sales, exchanges and options;
- C. To employ attorneys, auditors, depositaries, proxies and agents, with or without discretionary powers; and to keep any property in the name of an executor or a nominee, with or without disclosure of any fiduciary relationship, or in bearer form;
- D. To collect, pay, contest, compromise, or abandon claims of or against my estate, wherever situated; and to execute contracts, conveyances and other instruments including instruments containing covenants and warranties binding upon and creating a charge against my estate, and containing provisions excluding personal liability;

- E. To enter into any transaction authorized by this Article with trustees, executors or administrators of any other trust or estate in which any beneficiary hereunder has any interest, even though any such trustee or representative is also executor hereunder.
- To make any distribution or division of my estate in cash or in kind or both;
- G. To allot different kinds or disproportionate shares of property or undivided interests in property among the beneficiaries, and to determine the value of any such property;
  - H. To invest in any property, real or personal.

In the event my daughter shall not survive me or shall decline or be incapable of serving as such Executor, then and in that event, I hereby make, appoint and constitute my son, MICHAEL VALLONE, JR., as Successor Executor of this my Last Will and Testament, with full power and authority herein granted to the above-named Executor.
