D. A legal description of the real estate sufficient to identify it with reasonable certainty is as follows:



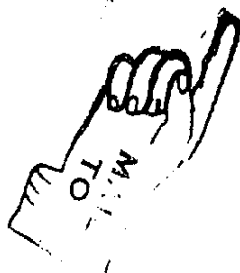
