Owner will be benefited by the Loan to Borrower, wants to assist Borrower in obtaining the Loan, and in order to do so, is willing to assign the leases described in this Agreement.

- 4. ASSIGNMENT. To induce Bank to make the Loan to Borrower and for other valuable consideration, the receipt of which is acknowledged by Owner, Owner assigns, bargains, sells and conveys to Bank all of Owner's right, title and interest in and to all rents and profile from the Property and all leases of the Property now or hereafter made, affective immediately upon the execution of this Agreement (sit of which are collectively known as the Collateral), which Collateral is described as follows:
  - A. All leases (Loases) on the Property. The term "Leases" in this Agreement shall include all agreements, written or verbal, existing or hereafter arising, for the use or occupancy of any portion of the Property and all extensions, renewals, and substitutions of such agreements, including subleases thereunder.
  - B. all guaranties of the performance of any party under the Leases.
  - C. the right to collect and receive all revenue (Rent) from the Leases on the Property new due or which may become due. Rent includes, but is not limited to the following: revenue, issue, profits, rent, minimum rent, percentage rent, additional rent, common area maintenance charges, purking charges, real estate taxes, other applicable taxes, socially deposits, insurance premium contributions, liquidated damages following default, cancellation premiums, "loss of rents" insurance or other proceeds, and all rights and claims which Owner may have against any person under the terms of the Leases.
- 5. COLLECTION OF RENT. Sweet shall give notice of Bank's rights to all Rent and notice of direct payment to Bank to those obligated to pay Rent. Prior to an Event of Default. O mer may continue to collect all Rent from the Leases on the Property now due or which may become due. Owner agrees to direct all tenants dust in certain instances they may be required to pay Rent due or to become due to Bank. Owner shall endorse and deliver to Bank any money orders, stacks or drafts which represent Rent from the above-described Property, apply the proceeds to the Obligations, and give notice of Bank's rights in any of said Rent and notice of direct payment to Bank to those obligated to pay such Rent. Bank shall be the creditor of each Lessee in respect to assignments for the benefit of creditors, bankruptcy, reorganization, rearrangement, insolvency, dissolution or receivership proceedings by Lessee, and Dwner shall immediately pay over to Bank all sums Owner may receive as creditor from such actions or proceedings. Also, Bank may collect or receive all payments paid by any Lessee, whether or not pursuant to the terms of the Leases, for the right to terminate, cancel or modify the Leases, and Cwo'x shall immediately pay over to Bank all such payments as Owner may receive from any Lessee. Bank shall have the option to apply any amounts received as such creditor to the Obligations. The collection or receipt of any payments by Bank shall not constitute Bank as being a mortgagee in possussion.
- E. APPLICATION OF COLLATERAL PROCEEDS. Any Rant or ther payments received or to be received by virtue of the Collateral, will be applied to any amounts Borrower owes Bank on the Obligations and or an be applied first to costs and expenses, then to accrued interest and the balance, if any, to principal except as otherwise required by law.
- 7. WARRANTIES. To induce Bank to make the Loan, Owner makes the following representations and warranties:
  - A. Owner has good title to the Leases and Rent and good right in assign them, and no other person has any right in them;
  - B. Owner has duly performed all of the terms of the Leases that Owner is obligated to perform;
  - C. Owner has not previously assigned or encumbered the Leases of the Rent and will not further assign or encumber the Leases or future Rent:
  - D. No Rent for any period subsequent to the current month has been collected or received from Lessee, and no Rent has been compromised. The term "Lessee" in this Agreement shall include all persons or entitles oblige led to Owner under the Leases;
  - E. Upon request by Bank, Owner will deliver to Bank a true and complete clay of an accounting of Rent which is current as of the date requested;
  - F. Owner has compiled and will continue to comply with any applicable landlord-lenant laws;

C. The making or furnishing of any verbal or written representation, statement or warranty to Bank which is or becomes false or incorrect in any material respect by or on behalf of Owner, Borrower, or any co-signer, endorser, surely or guaranter of the Obligations; or

Pallure to obtain or maintain the insurance goverages required by Gank, or insurance as is qualomary and proper for the Collateral (as herein defined); or

E. The death, dissolution or insolvency of, the appointment of a receiver by or on behalf of, the assignment for the benefit of creditors by or on behalf of, the voluntary or involuntary termination of existence by, or the commencement of any proceeding under any present or future federal or state insolvency, bankruptcy, reorganization, composition or debtor relief law by or against Owner, Borrower, or any co-signer, endorser, surety or guaranter of the Obligations; or

F. A good falth boilet by Bank at any time that Bank is insecure with respect to Borrower, or any co-signer, endorser, surely or guarantor, that

the prospect of any payment is impaired or that the Collateral (as herein defined) is impaired; or

G. Failure to pay or provide proof of payment of any tax, assessment, rent, Insurance premium, escrow or escrow deficiency on or before its due date; or

H. A material adverse change in Owner's business, including ownership, management, and financial conditions, which in Bank's opinion, impairs the Collateral or repsyment of the Obligations; or

1. A transfer of a substantial part of Owner's money or property.

10. REMEDIES ON DEFAULT. At the option of Bank, all or any part of the principal of, and accrued interest on, the Obligations shall become immediately due and pryable without notice or demand, upon the occurrence of an Event of Default or at any time thereafter, in addition, upon the occurrence of an Event of Default or at any time thereafter by Mortgagor under the Mortgage, Bank, at Bank's option, shall have the right to exercise any or all of the following rainedles:

A. To continue to collect directly and retain Rent in Bank's name without taking possession of the Property and to demand, collect, receive, and sue for the Rent giving proper receipts and releases, and, after deducting all reasonable expenses of collection, apply the balance as

fegally permitted to ine Crost, first to accrued interest and then to principal.

B. To recover reasonable atterneys' fees to the extent not prohibited by law.

C. To declars the Obligations immediately due and payable, and, at Bank's option, exercise any of the remedies provided by law, the Credit, the Mortgage or this Agreement.

D. To enter upon, take possession of, manage and operate all or any part of the Property, make, modify, enforce or cancel any Leases, evict any Lesses, increase or reduce Rerigidocate, clean and make repairs, and do any act or incur any cost Bank shall deem proper to protect the Property as fully as Owner could do, and to apply any funds collected from the operation of the Property in such order as Bank may deem proper, including, but not limiter, to, payment of the following: operating expenses, management, brokerage, alterneys' and accountants' fees, the Obligations, and toward the maintenance of reserves for repair or replacement. Bank may take such action without regard to the adequacy of the security, with or without any action or proceeding, through any person or agent, mortgages under a mortgage, or receiver to be appointed by a court, any knowner's possession.

The collection and application of the Rent or the entry upon and taking possession of the Property as set out in this section shall not cure or waive any default, or modify or waive any notice of default under the Credit, Militage or this Agreement, or invalidate any act done pursuant to such notice. The enforcement of such remedy by Bank, once exercised, shall continue for so long as Bank shall elect, notwithstanding that such collection and application of Rent may have cured the original default. If Bank shall the outtor elect to discontinue the exercise of any such remedy, the same or any other remedy under the law, the Credit, Mortgage or this Agreement may be asserted at any time and from time to time following any subsequent default. The word "default" has the same meaning as contained within the Credit or any other instrument evidencing the Obligations, and the Mortgage, or any other document securing, guarantying or otherwise relating to the Obligations.

In addition, upon the occurrence of any Event of Default, Bank shall be entitled to all of the comedies provided by law, the Credit and any related loan documents. All rights and remedies are cumulative and not exclusive, and Bank is entitled to all remedies provided at law or equity, whether or not expressly set forth.

#### 11. ENVIRONMENTAL LAWS AND HAZARDOUS SUBSTANCES.

A. As used in this paragraph:

- (1) "Environmental Law" means, without limitation, the Comprehensive Environmental Response, Compensation, and Liability Act ("CERCLA", 42 U.S.C. 9601 et seq.), all ledoral, state and local laws, regulations, ordinances, court orders, attorney general opinions or interpretive letters concerning the public health, safety, welfare, environment or r. Ha ardous Substance (as defined herein).
- (2) "Hazardous Substance" means any toxic, radioactive or hazardous material, waste, pollute it is contaminant which has characteristics which render the substance dangerous or potentially dangerous to the public neight, safety, welfare or the environment. The term includes, without limitation, any substances defined as "hazardous material." "toxic substances," "hazardous waste" or "hazardous substance" under any Environmental Law.

B. Owner represents, warrants and agrees that, except as previously disclosed and acknowledged in writing:

(1) No Hazardous Substance has been, is or will be located, transported, manufactured, treated, refined, or handled by any person on, under or about the Property except in the ordinary course of business and in strict compliance with all applicable Environmental Law.

(2) Owner has not and shall not cause, contribute to or permit the release of any Hazardous Substance on the Property.

- (3) Owner shall immediately notify Bank it: (a) a release or threatened release of Hazardous Substance occurs on, under or about the Property or migrates or threatens to migrate from nearby property; or (b) there is a violation of any Environmental Law concerning the Property. In such an event, Owner shall take all necessary remediat action in accordance with any Environmental Law.
- (4) Owner has no knowledge of or reason to believe there is any pending or threatened investigation, claim, or proceeding of any kind relating to (a) any Hazardous Substance located on, under or about the Property or (b) any violation by Owner or any tenant of any Environmental Law. Owner shall immediately notify Bank in writing as soon as Owner has reason to believe there is any such pending or threatened investigation, claim, or proceeding. In such an event, Bank has the right, but not the obligation, to participate in any such proceeding including the right to receive copies of any documents relating to such proceedings.

(5) Owner and every tenant have been, are and shall remain in full compliance with any applicable Environmental Law.

(6) There are no underground storage tanks, private dumps or open wells located on or under the Property and no such tank, dump or well shall be added unless Bank first agrees in writing.

(7) Owner will regularly Inspect the Property, monitor the activities and operations on the Property, and confirm that all permits, licenses or approvals required by any applicable Environmental Law are obtained and compiled with.

- (8) Owner will permit, or cause any tenant to permit, bank or frank's agent to enter and inspect the Property and review all records at any reasonable time to determine: (a) the existence, location and neture of any Hazardous Substance on, under or about the Property; (b) the existence, location, nature, and magnitude of any Hazardous Substance that has been released on, under or about the Property; (c) whether or not Owner and any tenant are in compliance with any applicable Environmental Law.
- (9) Upon Bank's request, Owner agrees, at Owner's expense, to engage a qualified environmental engineer to prepare an environmental audit of the Property and to submit the results of such audit to Bank. The choice of the environmental engineer who will perform such audit is subject to the approval of Bank.
- (10) Bank has the right, but not the obligation, to perform any of Owner's obligations under this paragraph at Owner's expense.
- (11) As a consequence of any breach of any representation, warranty or promise made in this paragraph, (a) Owner will indemnify and hold Bank and Bank's successors or easigns harmless from and against all lesses, claims, demands, liabilities, damages, cleanup, response and remediation costs, penalties and expenses, including without limitation all costs of illigation and reasonable afterneys' ties, which Bank and Bank's successors or easigns may sustain; and (b) at Bank's discretion, Bank may release this Agreement and in return Owner will provide Bank with collateral of at least equal value to the Property secured by this Agreement without projudice to any of Bank's rights under this Agreement.
- (12) Notwithstanding any of the language contained in this Agreement to the contrary, the terms of this paragraph shall survive any foreclosure or satisfaction of any deed of trust, mortgage or any obligation regardless of any passage of title to Bank or any disposition by Bank of any or all of the Property. Any claims and defenses to the contrary are hereby waived.
- 12. ADDITIONAL POWERS OF BANK. In addition to all other powers granted by this Agreement and the Mortgage, Bank also has the rights and powers, pursuant to the provisions of the illinois Code of Civil Procedure, Section 15–1101, at seq.
- 13. TERM. This Agreement shall remain in effect until the Obligations are fully and finally paid. Upon payment in full of all such indebtedness, Bank shall execute a release of this for remaint upon Owner's request.
- ADDITIONAL TERMS. Securing Letter of Credit #089301, dated August 30, 1993 and any subsequent renewals, extensions, substitutions and modifications of same.
- 15. GENERAL PROVISIONS.
  - A. TIME IS OF THE ESSENCE. Time is of the assence in Owner's performance of all duties and obligations imposed by this Agreement.
  - B. NO WAIVER BY BANK. Bank's course of dealing, or Bank's forbearance from, or delay in, the exercise of any of Bank's remedies, privileges or right to insist upon Owner's strict performance of any provisions contained in this Agreement, or other loan documents, shall not be construed as a waiver by Bank, unless any such waiver is in writing and is signed by Bank.
  - C. AMENDMENT. The provisions contained in this Agreement may not be amended, except through a written amendment which is signed by Owner and Bank.
  - D. INTEGRATION CLAUSE. This written Agreement and all documents executed concurrently horowith, represent the entire understanding between the parties as to the Obligations and may follow contradicted by evidence of prior, contemporaneous, or subsequent oral agreements of the parties.
  - E. FURTHER ASSURANCES. Owner, upon request of Bark, agrees to execute, acknowledge, deliver and record or file such further instruments or documents as may be required by Bank to secure the Note or confirm any lien.
  - F. GOVERNING LAW. This Agreement shall be governed by the award the State of ILLINOIS, provided that such laws are not otherwise preempted by tederal laws and regulations.
  - G. FORUM AND VENUE. In the event of litigation pertaining to this Agreement, the exclusive forum, venue and place of jurisdiction shall be in the State of ILLINOIS, unless otherwise designated in writing by Bank or other vise required by law.
