STIPULATION FOR INTERLOCUTORY SALE AND SUBSTITUTION OF DEFENDANT PROPERTIES

The United States of America, by its attorney, Michael J. Shepard, United States Attorney for the Northern District of Illinois, and claimant, Steven Griffin stipulate and agree as follows:

- This is a forfeiture action brought pursuant to 21 U.S.C. § 881(a)(6) and (a)(7), and 18 U.S.C. § 981 (a)(1)(A), and the Court has jurisdiction over this action pursuant to 25 U.S.C. § 1345 and 1355.

The parties agree that it is in the best interests of all the parties that the defendant properties at 4118 West 178th Street, Country Club Hills, Illinois, 5109-5111 South Indiana, Chicago, Illinois, 6033-6035 South Vernon, Chicago, Illinois, and 610 East 37th Place, Chicago, Illinois, be sold prior to the resolution of the forfeiture complaint currently pending before this Court.
- 7. In order for the sale of the property to be completed, the parties agree that the seizure of the real properties located at 4118 West 178th Street, Country Club Hills, Illinois, 5109-5111 South Indiana, Chicago, Illinois, 6033-6035 South Vernon, Chicago, Illinois, and 610 East 87th Place, Chicago, Illinois, and legally described above shall be released, that the properties shall be sold by the United States Marshals Service, and the net proceeds of that sale shall be substituted as the defendants herein.
- 8. Upon the sale of the properties, the interest of the claimant mortgage companies, Prudential Home Mortgage Company for the property located at 4118 West 178th Street; and Fleet Finance, Inc. for property located at 610 East 87th Street, being the principal and interest as set forth and stipulated to in the attached Stipulations for Entry of Decree of Forfeiture, attached and fully incorporated herein as Exhibits A and B, with interest accruing per diem as set forth in the stipulations until the date of sale, shall be satisfied out of the proceeds of the sale and

their claims in this action shall thereafter be deemed withdrawn.

9. The net proceeds remaining thereafter shall be deposited with the United States Marshals Service, shall be substituted as the defendants in this action in the place of the defendant properties, 4118 West 178th Street, Country Club Hills, Illinois, 5109-5111 South Indiana, Chicago, Illinois, 6033-6035 South Vernon, Chicago, Illinois, and 610 East 87th Place, Chicago, Illinois, and shall be retained by the United States Marshals Service pending further order of this Court.
