As of September 1993 Respondent is in arrears in the amount of SEVENTEEN THOUSAND AND ONE HUNDRED SEVENTY FIVE dollars (\$17,175.00) as ordered for child support + 9% statutory interest shall accrue on same. There has been a substantial change in circumstances with Father requesting a reduction in his current child support obligation, namely:

- i. He has filed for bankruptcy

1. Respondent shall pay to Petitioner the sum of \$80.⁰⁰ (EIGHTY dollars) per week as and for current child support, which is 30% of his present net income.

2. ~~The judgment~~ The judgment as to the arrearages shall be stayed for so long as father pays towards the arrearages in the amount of THIRTY FIVE (\$35⁰⁰) per week. If father fails to paid said sums towards the arrearage, then mother shall be allowed to proceed with enforcement.

3. Father shall continue to keep the minor child covered on his medical insurance policy and father shall pay 75% of all medical bills not covered by insurance and mother shall pay 25% of all medical bills not covered by insurance.

4. An order for withholding shall be prepared & served
