ORDER FOR POSSESSION

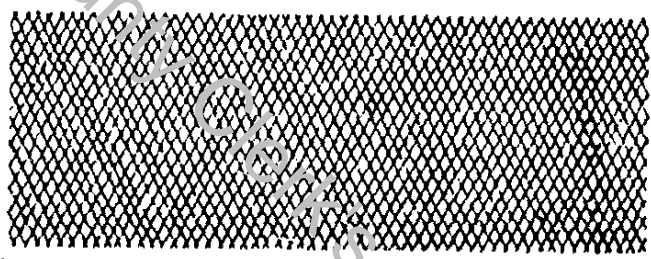
