BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Respecty and that the Property is unencumbered, except for encumbrances of record. 2. Funds for Taxes and Insurance. Lender may, at any time, collect and hold Funds in an amount not to exceed the maximum ensurement a lender for a federally related mortgage loan may require for Borrower's escrow account under the federal Real Estate Settlement Procedures Act of 1974 as amended from time to time, 12 U.S.C. 13. Loan Charges.
