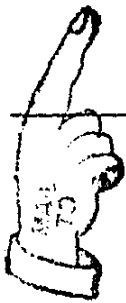

FIRST AMENDMENT TO
THE DECLARATION OF CONDOMINIUM OWNERSHIP
AND OF EASEMENTS, RESTRICTIONS AND COVENANTS
FOR
BEACH POINT TOWER CONDOMINIUM

This document is recorded for the purpose of amending the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (hereafter the "Declaration") for Beach Point Tower Condominium (hereafter the "Association"), which Declaration was recorded on October 6, 1977, as Document No. 24138343 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property"), legally described in Exhibit "A", which is attached hereto and made a part thereof.

This amendment is adopted pursuant to the provisions of Article XII, Section 7 of the aforesaid Declaration and Section 17 of the Illinois Condominium Property Act (the "Act"). Said provisions provide that this amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, provided the same is executed by the President of the Association or such other officer authorized by the Board of Managers of the Association (the "Board"), signed and acknowledged by the Board, and by Owners having at least 3/4 of the total vote, and provided further that it contains an affidavit by an officer of the Board, certifying that a copy of the change has been sent by certified mail to all mortgagees having liens of record against any unit ownership, not less than ten (10) days prior to the date of such affidavit.

RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Act; and

WHEREAS, the Board and the Owners desire to amend the Declaration in order to provide that the Association shall be responsible for repair and replacement of the coil and drip pan components of the heating/cooling elements serving the individual units and to clarify Association responsibilities; and

WHEREAS, the amendment has been executed by the President of the Association or such other officer authorized by the Board, signed and acknowledged by a majority the Board members and by Owners holding at least 3/4 of the total vote, due notice having been provided to all mortgagees holding liens of record against any unit ownership, all in compliance with Article XII, Section 7 of the Declaration and Section 17 of the Act.

NOW THEREFORE, the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for Beach Point Tower Condominium is hereby amended in accordance with the text which follows (additions in text are indicated by underline; deletions by ~~XXXXXX/XXXX~~):

1. Article VI, Section 1 is amended to read as follows:

ARTICLE VI

ASSESSMENTS-MAINTENANCE FUND

1. UNIT MAINTENANCE, REPAIRS AND REPLACEMENTS:

(a) Each unit owner shall furnish and be responsible for, at his own expense, all of the maintenance, repairs and replacements within his own unit; provided, however, such maintenance, repairs and replacements of the Common Elements as may be required for the functioning of the heating system and the plumbing within the unit, and for the bringing of water, gas and electricity to the unit, shall be furnished by the Association as part of the common expenses. Maintenance, repairs and replacements of the refrigerators, ranges and other kitchen appliances and lighting fixtures and other electrical appliances of any unit owner shall be at the expense of such unit owner. Maintenance, repairs and replacements of the Common Elements shall be furnished by the Association as part of the common expense. The Association may provide, by its rules and regulations, for ordinary maintenance and minor repairs and replacements to be furnished to units by Building personnel at common expense. It shall be the responsibility of each unit owner to provide for the maintenance, repair and replacement of all items which are situated within his unit boundaries or which run through and only serve his unit; however, with regard to the heating/cooling elements serving an individual unit, the Association shall be responsible for the repair and replacement of the coil and drip pan components and the cost thereof shall be a common expense. Any alteration of the heating/cooling elements serving a unit is subject to the prior written approval of the Board, and the Association shall not be responsible for the maintenance, repair or replacement relating to any alterations of or additions to the original heating/cooling elements (whether or not approved by the Board) but rather such expense shall be borne by the unit owner served by those heating/cooling elements.

2. Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
