and does authorize irrevocably the above mentioned GLADSTONE-NORWOOD TRUST & SAVINGS BANK in its own name to collect all of said rents, issues and profits arising or accruing at any time hereafter, and all now due or that may hereafter become due under each and every lease or agreement, written or verbal, existing or to hereafter exist, for said premises, and to use such measures, legal or equitable, as in its discretion may be deemed proper or necessary to enforce the payment of such rents, issues and profits, or to secure and maintain possession of said premises or any part thereof and to fill any and all vacancies, and to rent, lease or let any portion of said premises to any party or parties, at its discretion, hereby granting full power and authority to exercise each and every right, privilege and power herein granted as any and all times hereafter without notice to the grantor or its successors and assigns, and further, with power to use and apply said rents, issues and profits to the payment of any indebtedness or liability of the undersigned to the said GLADSTONE-NORWOOD TRUST & SAVINGS BANK or its agents, due or to become due, or that may hereafter be contracted, and also to the payment of all expenses and the care and management of said premises, including taxes and assessments, and the interest on such rents, issues and profits, if any, which may be in its judgment deemed proper and advisable.
