That on June 11, 1993, the owner owned the following described land in the County of Cook, State of Illinois, to-wit:

That on June 11, 1993 said contractor made a subcontract with the claimant to furnish plumbing system for and in said improvement, and that on August 24, 1993 the claimant completed thereunder delivery and installation of plumbing material.

That at the special instance and request of said contractor the claimant furnished extra and additional material at and extra and additional labor on said premises of the value of \$8,112.12 and completed same on August 24, 1993.

That said owner, or the agent, architect or superintendent of owner can, upon reasonable diligence, be found in said County.

That said contractor is entitled to credits on account thereof as follows: \$3,500.00, leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of \$4,612.27, for which with interest, the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.

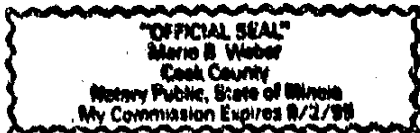
