MORTGAGE

THIS MORTGAGE IS DATED NOVEMBER 12, 1993, between Philip F. Torina and Cathleen M. Torina, whose address is 1016 N. 14th Ava., Melrose Park, IL 60160 (referred to below as "Grantor"); and Midwest Bank and Yrust Company, whose address is 1606 N. Harlem Ave., Elmwood Park, IL 60635 (referred to below as "Lender").

GRAIT OF MORTGAGE. For valuable consideration, Grantor mortgages, warrants, and conveys to Lender all of Grantor's right, title, and interest in and to the following described real property, toge her with all existing or subsequently erected or affixed buildings, improvements and fixtures; all easements, rights of way, and appurtenances; all water, "raish rights, watercourses and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royaltes, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters, located in Cook County, State of Illinois (I've "Real Property"):

improvements. The word "improvements" means and includes without limitation all existing and future improvements, lixtures, buildings, structures, mobile homes affixed on the Real Property, facilities, additions and other construction on the Real Property.

Indebtedness. The word "Indebtedness" means all principal and interest payable under the Credit Agreement and any amounts expended or advanced by Lender to discharge obligations of Grantor or expenses incurred by Lender to enforce obligations of Grantor under this Mortgage, together with interest on such amounts as provided in this Mortgage. DUE ON SALE - CONSENT BY LENDER. Lender may, at its option, declare immediately due and payable all sums secured by this Mortgage upon the sale or transfer, without the Lender's prior written consent, of all or any part of the Real Property, or any interest in the Real Property. A "sale or transfer" means the conveyance of Real Property or any right, title or interest therein; whether legal or equitable; whether voluntary or involuntary; whether by outright sale, doed, installment sale contract, land contract, contract for deed, leasahold interest with a term greater than three (3) years, lease-option contract, or by sale, assignment, or transfer of any beneficial interest in or to any land trust holding title to the Real Property, or by any other method of conveyance of Real Property interest. If any Grantor is a corporation or partnership, transfer also includes any change in ownership of more than twenty-five percent (25%) of the voting stock or partnership interests, as the case may be, of Grantor. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender.
