To this end the provisions of this Security Instrument and the Note are declared to be severable.
 - 15. Borrower's Cupy. Borrower shall be given one conformed copy of this Security Instrument.
- 16. Assignment v. Pents. Borrower unconditionally assigns and transfers to Lender all the rents and revenues of the Property. ADJUSTABLE RATE RIDER

THIS ADJUSTABLE RATE RIDER is made this TWENTY-NINTH day of NOVEMBER, 1993, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed ("Security Instrument") of the same date given by the undersigned ("Borrower") to secure Borrower's Note ("Note") to

(D) Limits on Interest Rate Changes

The interest rate will never increase or decrease by more than one percentage point (1.0%) on any single Change Date. The interest rate will never be more than five percentage points (5.0% higher or lower than the initial interest rate.

4. Fire, Flood and Other Hazard Insurance. Borrower shall insure all improvements on the Property, whether now in existence or subsequently erected, against any hazards, casualties, and contingencies, including fire, for which Lender requires insurance. This insurance shall be maintained in the amounts and for the periods that Lender requires. If the monthly payment amount calculated in accordance with paragraph (E) of this Rider decreased, but Lender failed to give timely notice of the decrease and Borrower made any monthly payment amounts exceeding the payment amount which should have been stated in a timely notice, then Borrower has the option to either (i) der and the return to Borrower of any excess payment, with interest thereon at the Note rate (a rate equal to the interest ate which should have been stated in a timely notice), or (ii) request that any excess payment, with interest thereo, at 'he Note rate, be applied as payment of principal. Lender's obligation to return any excess payment with interest on demand is not assignable even if the Note is otherwise assigned before the demand for return is made.
