- 1. Payments. I agree to make all payments on the secured debt when due. Unloss we agree otherwise, any payments you receive from me or for my benefit will be applied first to any amounts I owe you on the secured debr (exclusive of interest or principal), second, to interest and then to principal. If partial prepayment of the secured debt occurs for any reason, it will not reduce or excuse any subsequently scheduled payment until the secured debt is paid in full.
- 2. Claims against Title. I will pay all taxes, assessments, liens and encumbranceii on the property when due and will defend title to the property against any claims which would impair the lien of this mortgage. - 3. Insurance, I will keep the property insured under terms acceptable to you at my expense and for your benefit. You will be named as loss payed or as the insured on any such insurance policy.
