AS ADDITIONAL SECURITY or the payment of the indebtedness aforesold the Mortgagor does hereby assign to the Mortgagor all the rents, issues, and profits now due or which may hereafter become due for the use of the premises hereinabove described. The Mortgagor shall be entitled to collect and retain all of said rents, issues and profits until default hereunder, EXCEPT rents, boruses and royalties resulting from oil, gas or other mineral leases or conveyances thereof now or hereafter in effect. MORTGAGOR WILL CONTINUOUSLY maintain naza d insurance, of such type or types and amounts as Mortgagee may from time to time require, on the improvements now or hereafter on said premises, and except when payment for all such premiums has theretofore been made, he/she will pay promptly when due any premiums therefor. All insurance shall be carried in companies approved by the Mortgagee and the policies and renewals thereof shall be held by the Mortgagee and have attached thereto loss payable clauses in favor of and in form acceptable to the Mortgagee. In event of loss Mortgagor will give immediate notice by mail to the Mortgagee, who may make proof of loss if not made promptly by Mortgagor, and each insurance company concerned is hereby authorized and directed to make payment for such loss directly to the Mortgagee instead of to the Mortgagor and the Mortgagee jointly, and the insurance proceeds, or any part thereof, may be applied by the Mortgagee at its option either to the reduction of the indicatedness hereby secured or to the restoration or repair of the property damaged. In event of foreclosure of this mortgage, or other transfer of title to the mortgaged property in extinguishment of the indebtedness secured hereby, all right, title and interest of the Mortgagor in and to any insurance policies then in force shall pass to the purchaser or grantee.

Acceleration Clause: This loan may be declared immediately due and payable upon transfer of the property securing such loan to any transferse, unless the acceptability of the assumption of the loan is established pursuant to section 1814 of chapter 37, title 38 United States Code.

Funding Fee Clause: A fee equal to one-half of 1 percent of the balance of this loan as of the date of resister of the property shall be payable at the time of transfer to the loan holder or its authorized agent, as trustee for the Department of Veterens Affairs. If the assumer falls to pay this fee at this time of transfer, the fee shall constitute an additional debt to that already secured by this instrument, shall bear interest at the rate herein provided, and, at the option of the payee of the indebtedness hereby secured or any transferee thereof, shall be immediately due and payable. This fee is sufamatically waived if the assumer is exempt under the provisions of 38 U.S.C. 1829(b).

Processing Charge Clause: Upon aprilication for approval to allow assumption of this toan, a processing fee may be charged by the loan holder or its authorized agent for determining the creditworthiness of the assumer and subsequently revising the holder's ownership records when an approved transfer is completed. The amount of this charge shall not exceed the maximum established by the Department of Veterans Aria's for a loan to which section 1814 of chapter 37, title 38, United States Code applies.
