This Indenture, made this 8TH day of DECEMBER, A.D. 19 92 between

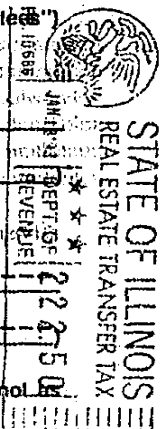
LaSalle National Trust, N.A., a national banking association, Chicago, Illinois, as Trustee under the provisions of a Deed or Deeds

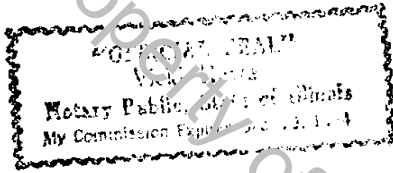
