And the Grantor, for itself, and its successors, does covenant, promise and agree to and with the Grantee, and its successors, that it has not done or suffered to be done, anything whereby the said real estate hereby granted is, or may be, in any manner encumbered or charged, except as herein recited; and that it WILL WARRANT AND DEFEND the said real estate against all persons lawfully claiming, or to claim the same, by, through or under it, subject only to:

- (1) general real estate taxes not due and payable at the time of closing;
- (2) the Condominium Property Act;
- (3) the Declaration, including all amendments and exhibits thereto;
- (4) applicable zoning and building laws and ordinances and other ordinances of record;
- (5) encroachments, if any, (including, without limitation, encroachment of the building onto the alley located south of the above described real estate);
- (6) acts done or suffered by Grantee or anyone claiming by, through or under Grantee;
- (7) rights of the tenant under the existing lease of the Unit, if any;
- (8) utility easements, if any, whether recorded or unrecorded;
- (9) leases and licenses affecting the Common Elements;
- (10) covenants, conditions, restrictions, permits, easements and agreements of record; and

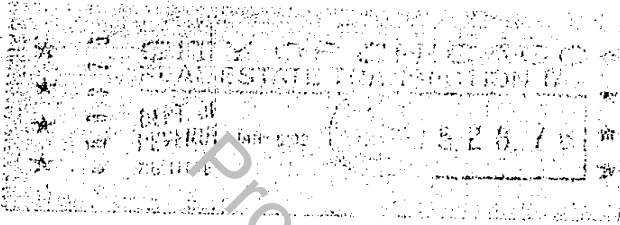

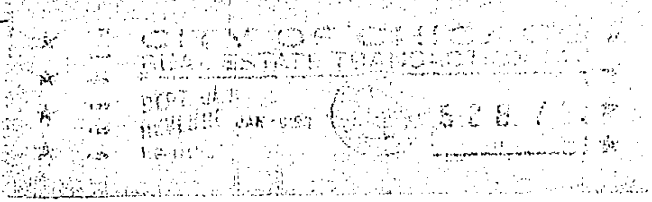
