MEMORANDUM OF ROOFTOP LEASE AGREEMENT

This Momorandum of Lease is made this 23rd day of Hertomber 1992 between LaSalle National Trust, N.A., not individually, but 2 as Successor Trustee to LaSalle National Bank under Trust 8 as Agreement dated March 26, 1984 and know as Trust No. 107822 (Landlord) and Chicago SMSA Limited Partnership (Tenant).

The Lease is for an initial term of five (5) years beginning December 1, 1992 and earling November 30, 1997. The Initial Lease term can be renewed for three (3) successive five (5) year terms by giving the Landlord written notice of its intention to do so at least six (6) months prior to the Expiration Date or the end of any Renewal Term as the case may be. The maximum date to which the Lease may be extended is twenty (20) years from the commencement date.

Subject to the terms and corditions of the Lease, all antennas added to the leased rect premises and the telecommunication equipment in the Building Space added by the Tenant and any transmission lines and conduits installed by Tenant in the Riger Space shall be Tenant's property and shall be removed by Tenant after termination of the Lease. Any heating and ventilating and air conditioning equipment and any electrical equipment installed by Tenant on other parts of the Property shall become the property of the Landlord and shall not be removed by Tenant after termination of the Lease.

The rights and obligations of Landlord and Tenant small be construed solely by reference to the provisions of the Lease and in the event of any conflict between the provisions of the Lease and those of this Memorandum of Lease, the provisions of the Lease shall control.

If the mortgage or trustee named in any mortgage or trust deed hereafter made (Mortgagee) shall agree that, if it becomes the owner of the Property by foreclosure or deed in lieu of foreclosure, it will recognize the rights and interest of Tenant under the Lease and not disturb Tenant's use and occupancy of the Premises if and so long as Tenant is not in default under the Lease, then all or a portion of the rights and interests of Tenant under this Lease shall be subject and subordinate to such mortgage or trust deed and to any and all advances, and to the interest therein, and all renewals, replacements and extensions thereof.
