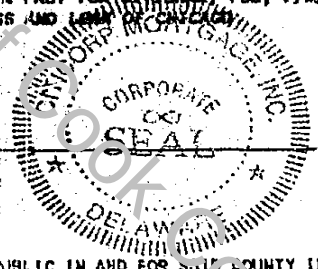

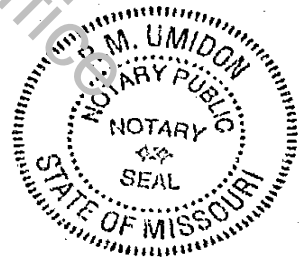

The land referred to in this commitment/policy is situated in the State of Illinois, County of COOK, and is described as follows:

**PARCEL 1:**
